

Someone should explain to the common people why world science has preferred thermodynamics to fluid dynamics to produce primary energy from which to extract electrical energy, when it would have been much more logical and linear to use fluid

dynamics that does not produce pollution. Furthermore, air and water are everywhere and cost nothing. The entire world ruling class, public and private, is silent on this subject and continues to be silent after ten years from the inventions of undersigned called submerged and compressed hydroelectricity that without public and private funding, the undersigned has been able to use them only virtually to produce inventions that are simultaneously energetic and purifying, in the general indifference of the entire world ruling class, including the scientific one.
