They are also and above all the interactive energy and purification solutions, which are very different from those we pay through the bills of the municipalities and fuel distributors. In fact, we pay for inefficient public services and fuels that produce more harm than good to humanity because by exploiting single scientific principles, they are unable to close all the

After the world wars of the last century and the collapse of the Berlin Wall on November 9, 1989, the planet Earth should have found world peace and harmony, but the seed of capitalism had already taken root because communism was not accompanied by adequate scientific research. The United Nations did not prove to be up to the task, having concentrated above all on political, economic and humanitarian agreements. Instead, they should have been, above all, a set of impartial scientific and technical bodies, to coordinate world development, safeguard the planet's natural resources, help the poorest countries to keep themselves at the same scientific and technological level as others. How do world politicians and the United Nations Organization, which manages COPs and WIPO, fail to understand that this system cannot work. Indeed, it also encourages public research to work for the profit of multinationals and rewards the worldwide corruption of public bureaucrats, politicians, who hide research and inventions that are not attractive to the only customers who are multinationals. These cannot convert to energies that do not sell or transform raw materials. First they have to amortize all the investments made in the current energies and then they will switch to cleaner energies. Unfortunately, at the point where we are, even clean energies are of little use if they are not sustainable. They cannot be

sustainable if they are not interactive. This world science has not yet understood.
